SECTION 4: FIRST AID MEASURES

Description of First Aid Measures

SECTION 5: FIREFIGHTING MEASURES

Extinguishing Media

Fire hazard: Combustible Dust. Dust explosion hazard in air. Supports combustion at high temperatures. Under conditions of fire this material may produce: Carbon dioxide and/or Carbon monoxide. The product is not classified as flammable, but may combust on heating or with fire.

Explosion hazard: Avoid dust clouds in combination with static electricity. Dust clouds can be explosive.

Reactivity: Stable at ambient temperature and under normal conditions of use.

SECTION 7: HANDLING AND STORAGE

Methods and material for containment and clean up

Methods for cleaning up: Collect spilled material. Avoid dust formation when cleaning up spills. The vacuum cleaner should be equipped with a HEPA filter to prevent the release of particles during cleaning. Use a good one. Visible dust clouds, layers of dust on floors, edges and equipment, or dust that will escape from machinery indicate that action is needed to reduce dust at the source. **Cleaning method:** A spill can make a smooth surface slippery, whether dry or wet.

Precautions for Safe Handling

Precautions for safe handling: Take precautionary measures against static discharge. Visible dust clouds, layers of dust on floors, ledges and equipment, or dust leaking from machinery indicate that action is required reduce dust at source.

Hygiene measures: Handle in accordance with good industrial hygiene and safety procedures. Wash hands and other exposed areas with mild soap and water before eating, drinking, or smoking and again when leaving work
